10. Prescription Drug Abuse

California ACEP has adopted guidelines similar to San Diego for Safe Prescribing of Controlled Substances from the Emergency Department. San Diego County has good results with these guidelines. LA County should release a plan to use the guidelines in all 77 Emergency Departments. Orange County is on the edge of getting their physicians together. Any ED can start using the guidelines. They are available in English and Spanish, but are not yet on California ACEP website, pending further endorsements.
