 - c. Dr. Lev, Gertz, Norton, Fenton, Stock all attending the ACEP Council. One of the many issues discussed was nurse practitioners' ambitions to be treated like doctors: "the brain of a doctor, the heart of a nurse." The issue of contract management

groups was discussed as Dr. McNamara of AAEM presented a couple resolutions and ran for the board unsuccessfully. Dr. Lev's resolution on the complications of marijuana was passed.

- e. EMBC
 - i. Dr. Lev met with Dr. Mauer of EMBC to discuss joint projects and unity of independent emergency physicians. VEP, a large group was part of EMBC, but they have now merged with US Health Solutions. Now that EMBC represents smaller groups, there is opportunity for more interaction.
 - ii. EMBC is sponsoring an EM Academy under ACEP to educate emergency physician on how to create an independent group. IEPC members are invited to become faculty.
