- 9. Anthem no pay: OON=Lawsuit; IN=arbitration. Should CAL ACEP be the hub for this?
 - a. Anthem is currently auditing all level 5 charges. If Anthem decides the level 5 claim isn't a level 5, Anthem refuses to pay. This is affecting both in and out of network providers.
 - b. Out of Network providers have moved forward with a formal lawsuit while in network providers are going through arbitration.
